- **204. Building C Re-roof:** Continues and is close to completion.
- **203. Bldg. B 2<sup>nd</sup> Floor:**\_ Same status. DSA approved and waiting for nursing program to move into new building.
- **202. Bldg. K Reno:** Architect, Lionakis, has met further with staff to identify mechanical systems and has presented the first design development renderings with the programming committee to present further enhanced elements of the renovation based on input of previous meetings.
- **201. Bldg. J Reno:**\_HGHB architects presented in March their schematic designs incorporating the input of the second meeting with the design/programming committee. Individual meetings will progress to detail the elements of each area of the building per program.12500

- **200. Bldg. D and E:** Inside elevator in E building is completing structural components, following this is the modification of the shaft floor to meet code and then installation of the elevator cab which is on site.
- **199. Nursing:** Framing and rough in of the mechanical, electrical, plumbing system continued through March. Areas of roof still need to be enclosed and has pushed back start of drywall and insulation. Information to enclose the roof has been provided to the contractor who has scheduled the completion of the roof and get the building closed in asap. Electrical, mechanical and plumbing continue rough-in.
- **198. Soledad:** Exterior landscaping and commissioning (final system checks and training on use of systems) was completed in March. Scheduling and installation of owner provided equipment, and fixtures has started following contractor's return of the building back to the district.
- **197. King City:** Remaining solar and ADA area at front of the building were completed in March. Scheduling and installation of owner provided equipment, and fixtures has started following contractor's return of the building back to the district.
