- 1) Correct error made in most recent revision of AS Kinesiology. The required math course for this degree should be MAT 13 rather than MAT 126. This degree serves transfer students and prior to last revision reflected a transfer level math requirement. This action corrects an error in the most recent revision of the local degree AS Kinesiology.
- 2) Correct error made in most recent revision of AS Vocational Nursing. The certificate indicates that a student can take BIO 11 or BIO 5, 6 and 6L. The degree should have the same option but it isn't listed. The degree page should indicate as follows:

BIO-11* – Intro to Human Anatomy & Physiology	4.0

BIO-5* — Human Anatomy	(4.0)
AND	
BIO-6* – Introductory Physiology	(3.0)
AND	
BIO-6L* – Physiology Lab	(2.0)

- 3) Correct error in catalog page for AS-T Agriculture Business. ABT 58 should be in the "List B (0-9 units required)" section rather than in the core major required courses (where it is currently showing in catalog" in order to match the TMC.

 Program submitted to COCI correctly but catalog page is in error.

 - 1) ESL 239 English Language Skills for Work (1 unit) Course has not been offered in over 5 years. The ESL 290/690 lab series has taken the place of this course.
 - 2) ESL 639 English and Spanish in the Community (noncredit 48-54 hours) Experimental course that developed into ESL 295/695 in both credit and noncredit options.
