## v. Experimental New Course, One Reading, Action

<u>From PCAH 7<sup>th</sup> ed</u>. "One type of stand-alone credit course is the "experimental" course. In general, an experimental course is one for which full information on some approval criterion, such as feasibility or need, cannot be determined until the course is actually offered on a pilot basis. After an experimental course has been offered twice, it must be submitted to the college curriculum committee for approval as a regular course, or the college must discontinue offering the course as experimental. As noted above, experimental courses must be submitted to the Chancellor's Office curriculum inventory system and receive a control number in order for the college to claim apportionment. "

This course proposal grew from an experiment done with a section of an existing noncredit course. The course is taught in collaboration with an Middlebury Institute of International Studies Spanish class. The committee had significant discussion about better aligning the required courses in each certificate with the required courses in each emphasis of the degree. Also, the committee questions some courses that were in a certificate but not in the degree.

The inability to list emphases of the AS degree Agriculture with Emphasis in the transcript means that earning the certificate will be a way for students to have the specific title in their transcript. The committee discussed the possibility of splitting the degree with emphasis into separate degrees to achieve that purpose. Whether revision or new degree a proposal packet with narrative will have to be submitted to CCCCO. So there is no timeline benefit to revision over new degree as there was previously.

Faculty representative agreed to go back to discipline to discuss whether to split the degree and then, if needed, to align the certificate courses.
