Chair showed the committee sample DE Addenda from other colleges and our own draft of the Modified DE Addendum in a Google forms format. Suggestion to change the top part of the form to be more like the Modesto JC version with boxes to indicate modality, emergency only, and whether that modality was being requested.

A discussion of what basics are required for accessibility led to the <u>WCAGAA</u> <u>standards</u> which list levels of accessibility with level A being the minimum. Some of the items discussed were color and contrast, alt text for images, hierarchical content on pages using headers, etc. Another requirement could be for faculty to indicate which tools will be used to check accessibility—perhaps a checkbox indicating tools used. Examples include how Canvas pages, pdfs, how slide decks, etc. will be checked for accessibility.
