**CALL TO ORDER & INTRODUCTIONS**

**INFORMATION/DISCUSSION/PRESENTATIONS**

1. ACCJC Draft External Evaluation Report Update Willard Lewallen  
Dr. Lewallen reported that he received the report a few weeks ago. He and Dr. Lolland spent quite a bit of time reviewing "errors of fact" (e.g., data, names of committees, etc.) from the visiting

team. There were a couple of items that they believed fell into a different category called "Inaccuracies," which came from the Commission's report. Dr. Lewallen's report (communication) goes to the readers assigned to review our accreditation report. He can't share the report yet, but he's pleased to share that the report is consistent with the Exit Report.

Dr. Lofman inquired as to who should see the report to review errors of fact. Dr. Lewallen advised his approach has always been that the review is done by the superintendent/president and the accreditation liaison officer. They did reach out to folks as needed for facts.

## 2. ACCJC Updates

Willard Lewallen

Dr. Lewallen shared the following updates:

- The ACCJC is doing a Commission Development Workshop (CDW) in October 2019 to conduct an evaluation on itself.
- The Commission will discuss the meaning of the Mid-Term Report. They will review expectations of QFEs.
- The Commission will also discuss how to monitor Annual Fiscal Reports, and how they will follow up with institutions.
- There are still 128 standards – a lot of the standards have been combined, but there are still many that overlap. Dr. Lewallen stated that the Commission will work on the process for reviewing the standards.
- Most exciting update from ACCJC is that they are making changes to the visit itself. They want to move away from a standards based evaluation (i.e., checking the box) to the areas of inquiry approach utilized by WASC. This will ultimately change the way the institutional self-evaluation report is written – report would be shorter. The visiting team would also be smaller.

## 3. Partners in Excellence ACCJC Conference Report Out

Dr. Lofman attended the conference and reported that this was a well-attended conference. He presented on "Hartnell College and High Performance Organizations," which was attended by Lisa Storm.

## 4. Governance Survey Results

Mr. Hooper reviewed the survey results posted on the council's website. It was noted that only five members responded to the survey. Members present agreed that the strengths of the councils are as follows:

- Encouragement to participate.
- Strong chair leadership.
- Meetings conducted in a constructive manner.

Dr. Lolland shared the ACCJC's survey results, which Dina will post for everyone's review.

6. Governance Structure Change:  
Combine Accreditation Council and Academic Affairs Council? All  
Members considered the pros and cons of combining the two councils. Mr. Beymer advised that he's been a member of both councils, and he doesn't envision that this would work as one combined council.

Dr. Lolland stated that we need to consider how we will monitor the progress of the Quality Focus Essays (QFEs). Dr. Lewallen advised that the co-chairs of the standards are also responsible for the Mid-Term Report.

The consensus of the group was to hold next year's meetings twice next semester.
