# 4. 2020 ACCJC Annual Report

Matt Trengrove presented data from the ACCJC Annual Report 2020 to the CPC with the following findings:

- Our institutional benchmarks (e.g., In-class success rates, unduplicated headcount, certificates/associates awarded, institutional transfer) have continued to improve
- The ISS standards that were reviewed and approved by CPC in 2019SP, are not included in this report, which covers the 2016-17, 2017-18 & 2018-19AY. The aspirational targets apply to the 2019-20AY, which will be covered in the 2021 Annual Report.
- The 'Graduation Rate per US Education Department website reports only 19%, while the College Navigator IPEDs site reports an overall graduation rate of 33%. We've asked IPEDS to validate this discrepancy
