4. Advocate Reporting

Mr. Nevarez updated the council on the reporting system the college has held for the past 6 years. This reporting system is for anyone to use to report any issues on campus that goes against the student code of conduct as well as mental health crisis's on campus. Basic needs will be a subject added to Advocate reporting for anyone needing basic needs. There is a link on the Hartnell website to "report a behavior". The link takes the user to the Behavioral Intervention Team (BIT) and includes the groups mission and goals. There are two reporting modules. The first is report an incident and the second is to report a behavior. Mr. Nevarez walked members through filling out a report. Dean Johnson informed she has been advising people to call the police when there is something urgent happening on campus because our campus safety are only observers. Mr. Nevarez informed that Campus Safety should always be called first so they can assess the situation and made the call on if police or other emergency services will need to be called. Ms. Ting asked about the turnaround time when submitting an Advocate report. Mr. Nevarez informed that he receives an email the moment the Advocate report is submitted and he is regularly on the system. When it comes to harm to self or others then campus safety should be called immediately before submitting the Advocate report. The Advocate report is an incident-reporting tool but should not be used for emergency purposes. Ms. Raras suggested adding verbiage on the website to the Advocate report indicating if the situation is an emergency to call campus safety and complete the form after reporting the incident to campus safety. - 6. Emergency Conditions Allowances (ECA) Presentation Romero Jalomo Dr. Jalomo shared the presentation that was given at the February 21, 2023 board meeting. He informed the members that Title 5 provides the State Chancellor's Office authority to hold a district's enrollment (FTES) stable at a level reported prior to the occurrence of the emergency. The requirements are that districts must

complete an application that contains the Emergency Conditions Recovery Plan and certification confirming that the district meets specific eligibility requirements. The application was approved on October 14, 2022. The mid year report to the board must be submitted to the State Chancellor's office by February 28, 2023.
