## INFORMATION/DISCUSSION/PRESENTATIONS

- 1. Student Enrollment Targets for 2020-21 Romero Jalomo
  Dr. Jalomo shared the enrollment numbers. The data shows we have 3257 FTES as of
  October 7, 2020. The target is 3540 FTES. The JPA stands for Joint Powers Authority which is
  the part of the safety consortium located in Morgan Hill. These are students who live in our
  service area taking courses in public safety. We purchase these enrollment numbers. Positive
  attendance courses will be added later in the semester. Those courses are courses that are
  based on your attendance like gym courses where students swipe their ID card and log hours.
  These reports can be populated by clicking the link on the FlexIT web link located on the
  document. The link can only be accessed through the Hartnell network. The college will not
  be purchasing the full 300 from the JPA, the college plans to phase that out. Each year the
  college will reduce their purchase by 100 FTES. The chancellor's office will start funding 1%
  growth in the 2023-24 year.
- 2. Update on Meta Majors Pathways Development Carla Johnson Dean Johnson gave an update regarding the Meta Majors Pathways. She shared the page from Bakersfield College. Hartnell's page will be similar and have Hartnell branding. The college will be responsible for updating the content. High School students would hear about this feature by the Pathways Team who goes out and assists HS students with their steps to success. Any incoming student would learn about this feature through the orientation and steps to success. The link will be on the college website for student use.
- 3. Adult Education Program Update

She became aware by working with Mr. Nevarez in Student Life. Ms. Romero stated she likes the term Stepping Stones as opposed to Late Start Courses. She does understand how that term may make some students feel rushed or overwhelmed. Ms. Moorhouse stated some students who sign up for late start courses sometimes forget they signed up for them once they start and no not show up on time.
