3. Supporting Undocumented Students

DACA Provides two-year protection from deportation. They would lose that at the federal level but at the state level they would be allowed to attend college. A student can attend college without DACA but the status can assist with financial aid. Free legal services clinic for undocumented students that are held once a month on the main campus as well as in King City. Expanding services in the spring. Partnered with the United Farmworker Union.

4. Fall 2019 Enrollment from Local High Schools

Dr. Jalomo shared the data regarding the fall 2019 High School enrollment. The data shows the 2019-2020 shows that the number of high school graduates who have enrolled in Hartnell College. Dr. Jimenez asked if the Salinas Valley Promise program is being marketed at the high schools. Mr. McGriff stated the pathways team does inform high school students of the Salinas Valley Promise program.

5. CSU Quantitative Reasoning Requirement

Dr. Jalomo shared the data located on the council website. There are schools in the Salinas high and at Carmel high and Monterey hi are not going to have that problem. This data is a struggle going on with the CSU right now. The report stated the CSU's are proposing to require 4 years of math at the high school. High School grad rate in Monterey county is at 92%. The A-G completion rate is only 33% county wide two years ago. Now it stands at 39%. It is low because not everyone completes the A-G requirements. Mr. McGriff states that the high school requirements do not align with the A-G requirements. If CSU is trying to get to a point where the high schools align to the A-G requirements, then the community colleges will have lack of students. The fear is the pressure from high schools will be put on the

elementary schools for not preparing their students for High School.
