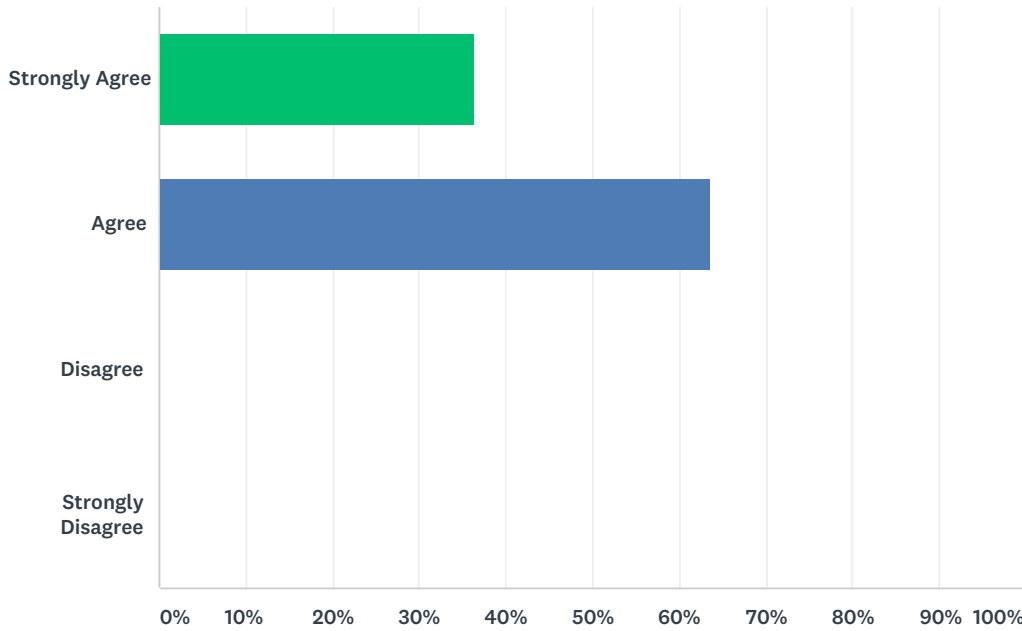

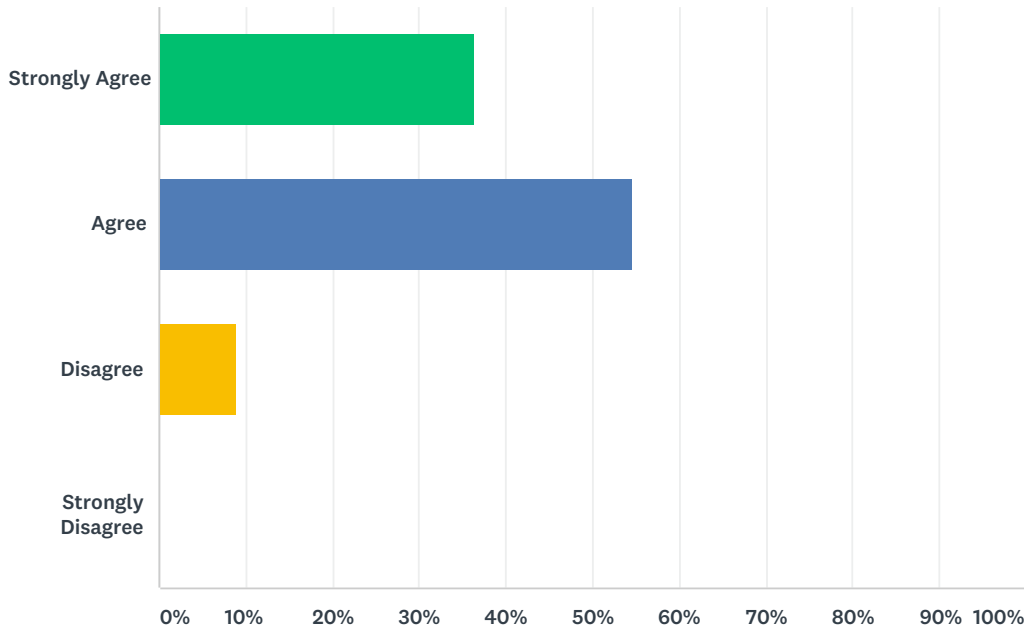

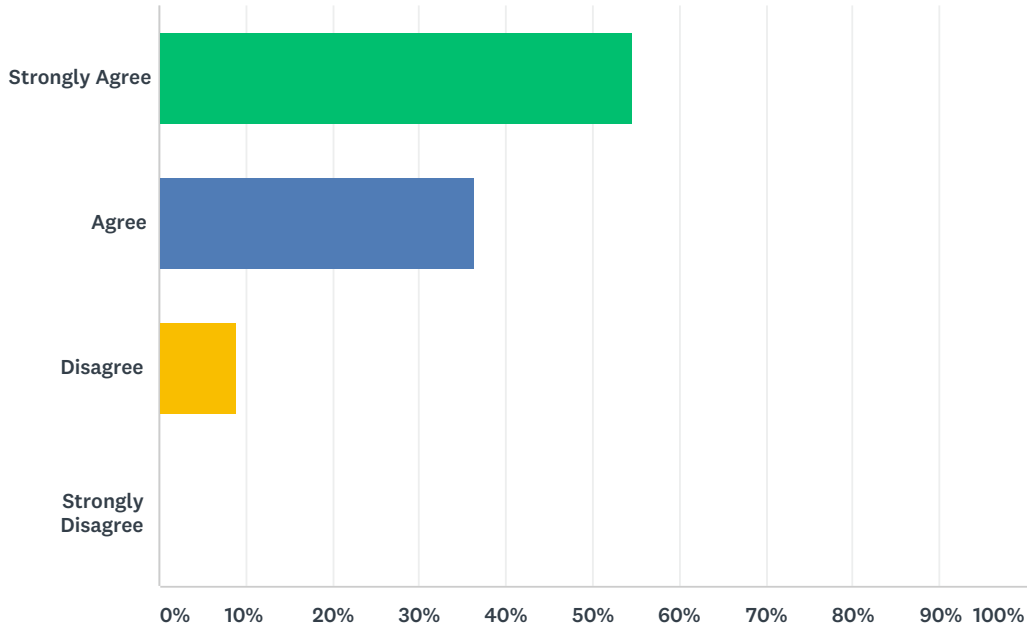

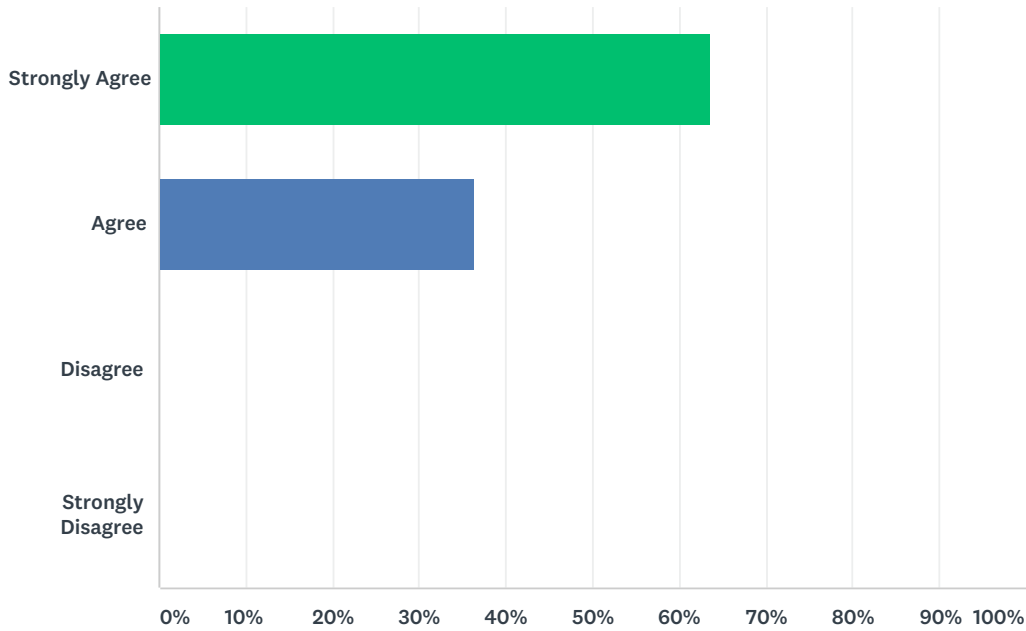

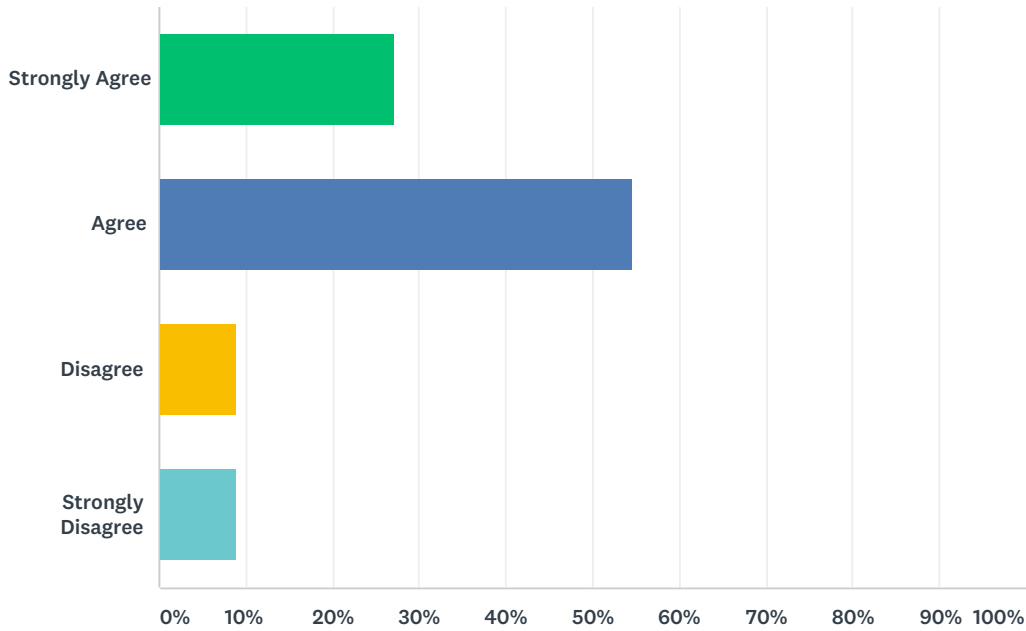

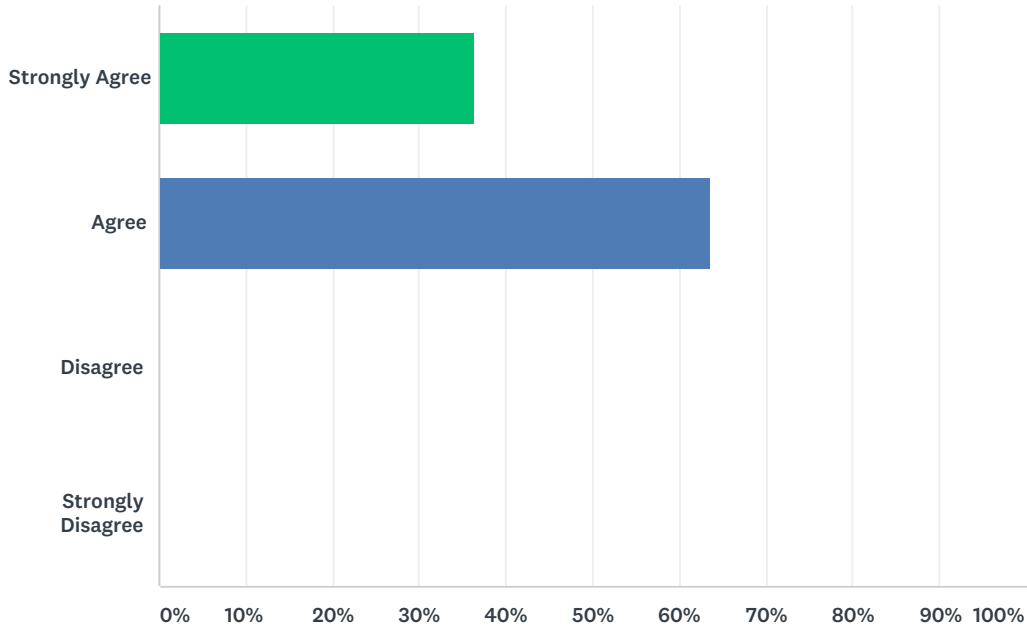

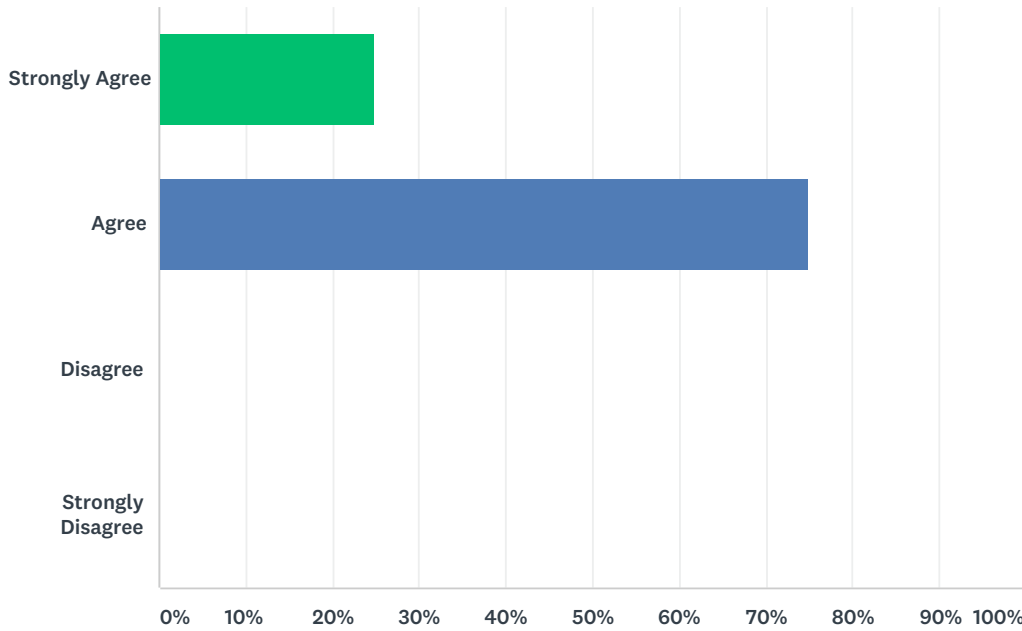

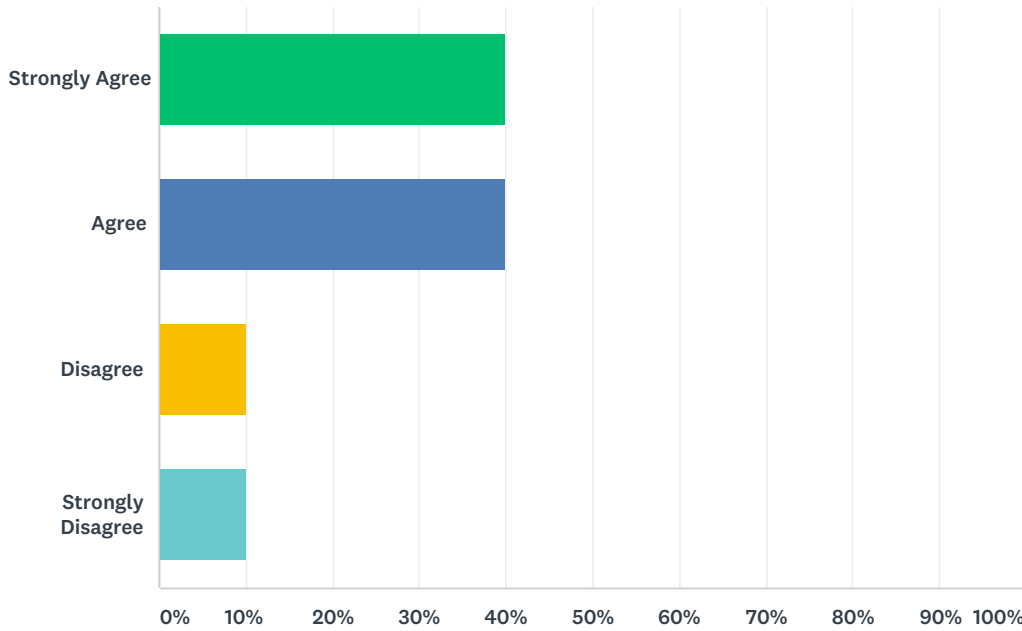

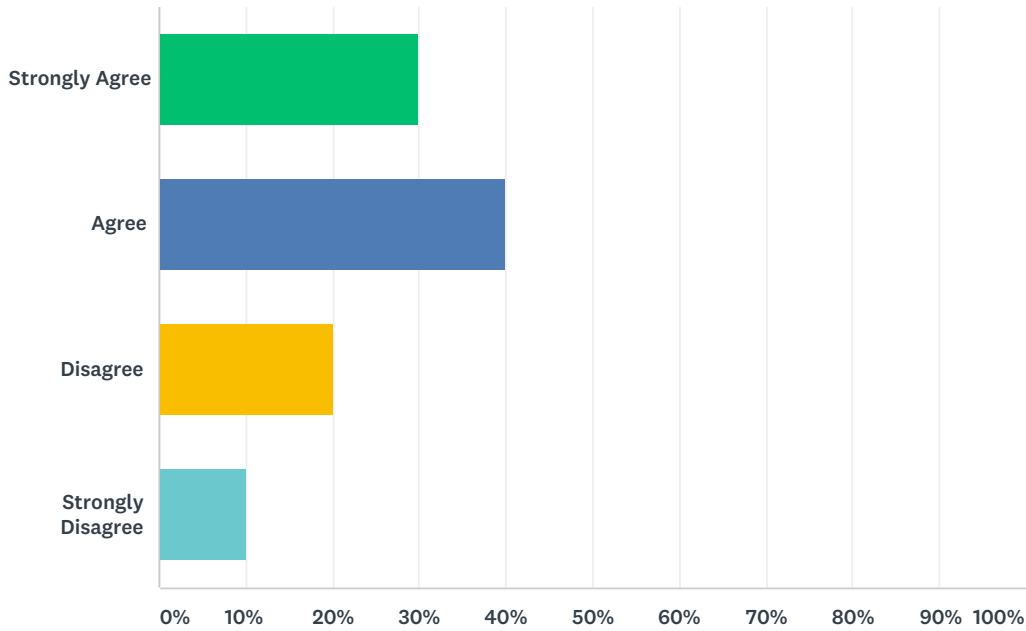

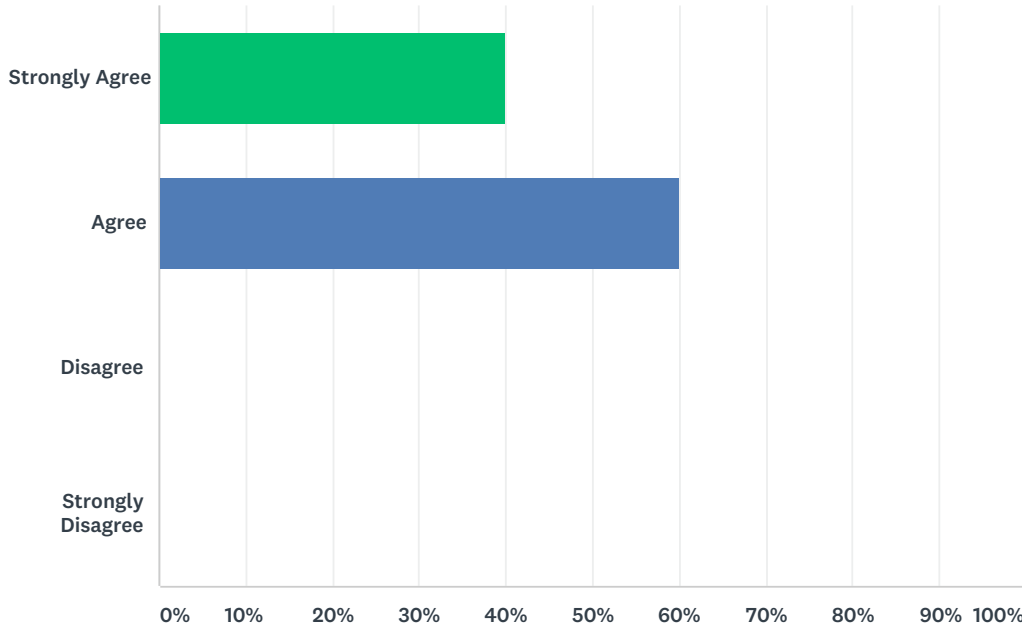

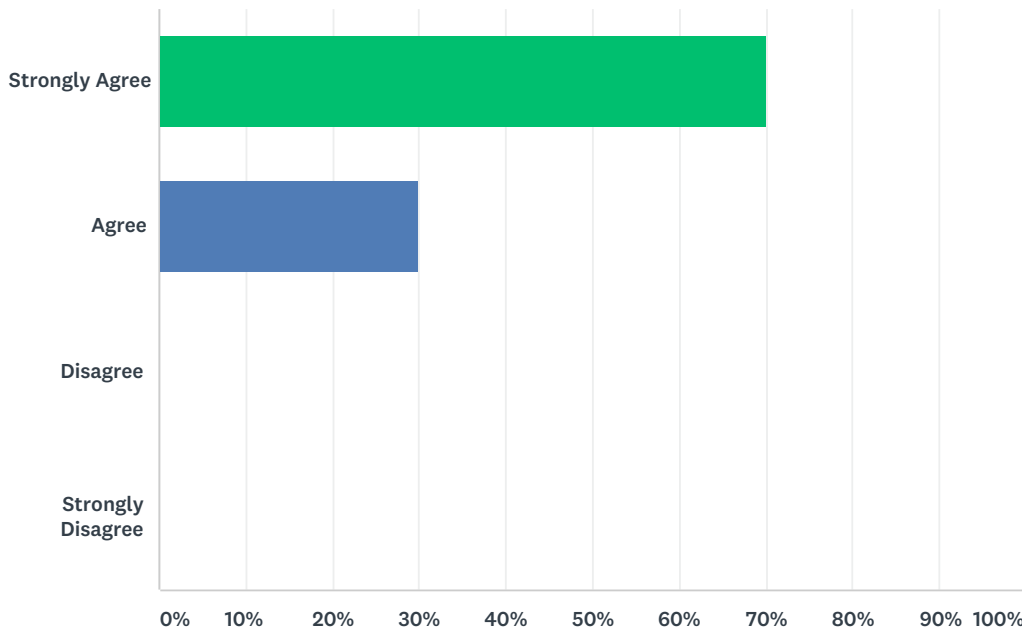

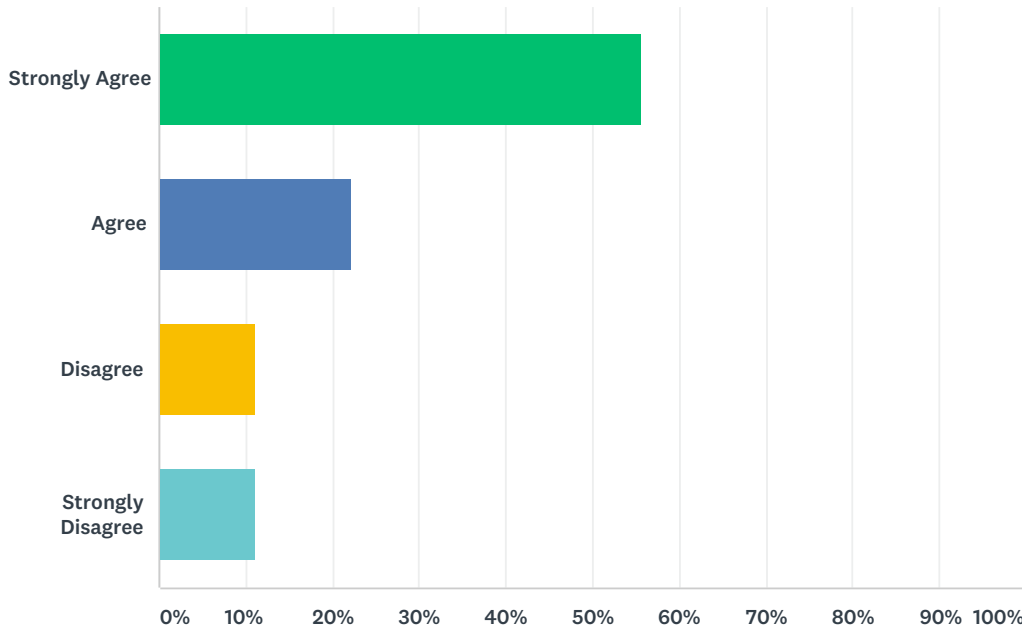

Members are not discouraged from participating, however, there are power struggles in place that hinder certain members (i.e. students) from participating confidently. For example, I was at a meeting where faculty were arguing the need to implement a new online/social interaction platform. IT staff asked how this new platform differed from software currently in use (Cranium Cafe, Zoom), but faculty appeared defensive. Someone asked what the student thought, student reported that he did not personally like it and did not think his friends would utilize it. Faculty replied with a statement about how that was the one student's opinion. It seemed to me that because the student's opinion did not align with what faculty were pursuing, the student's opinion was dismissed. Student no longer participated for the rest of the meeting. I was uncomfortable with this interaction.

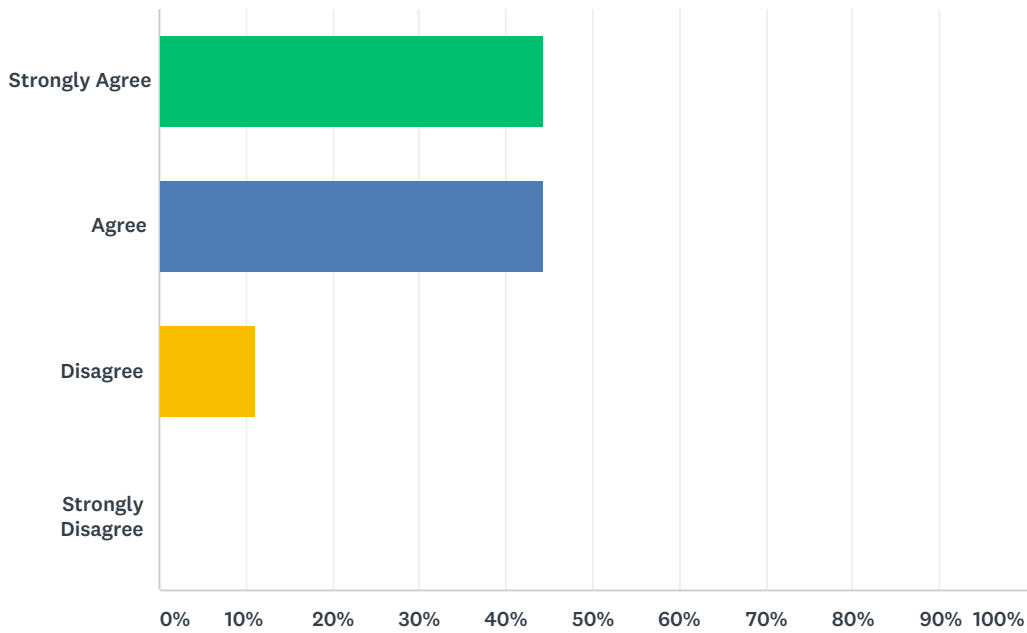

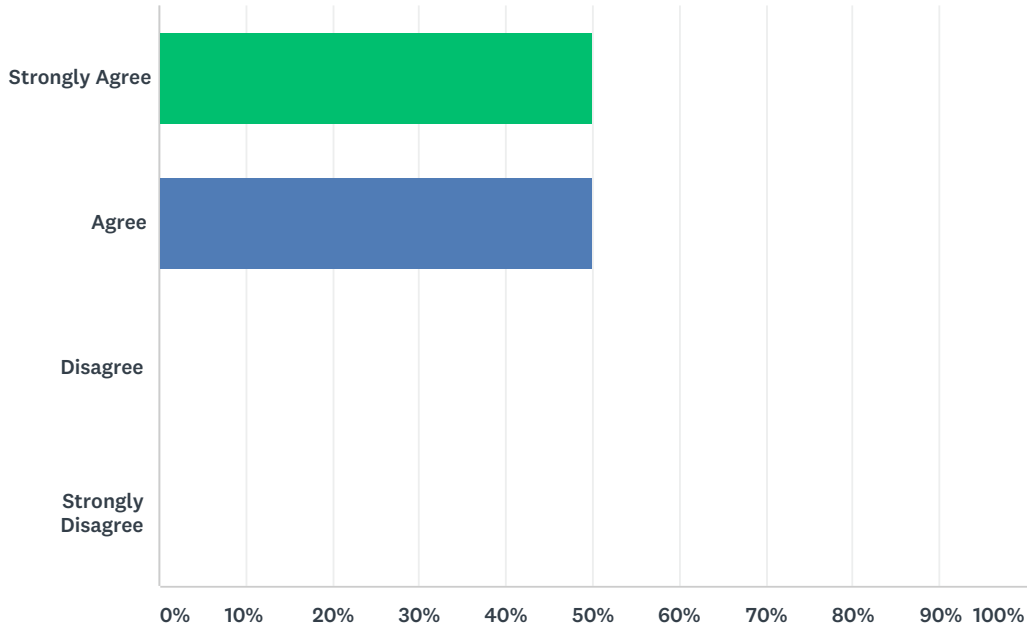

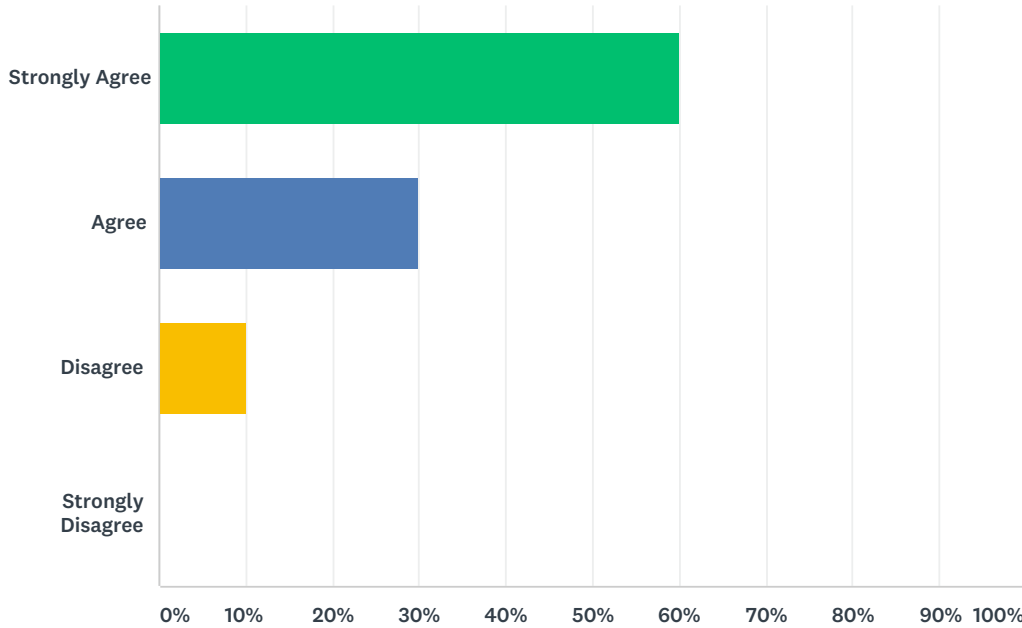

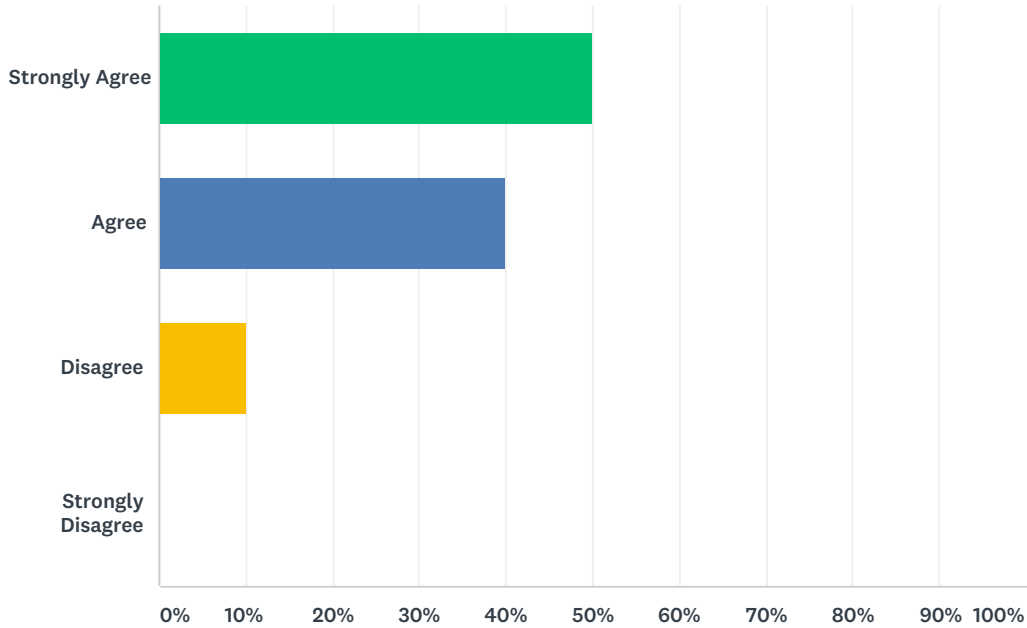

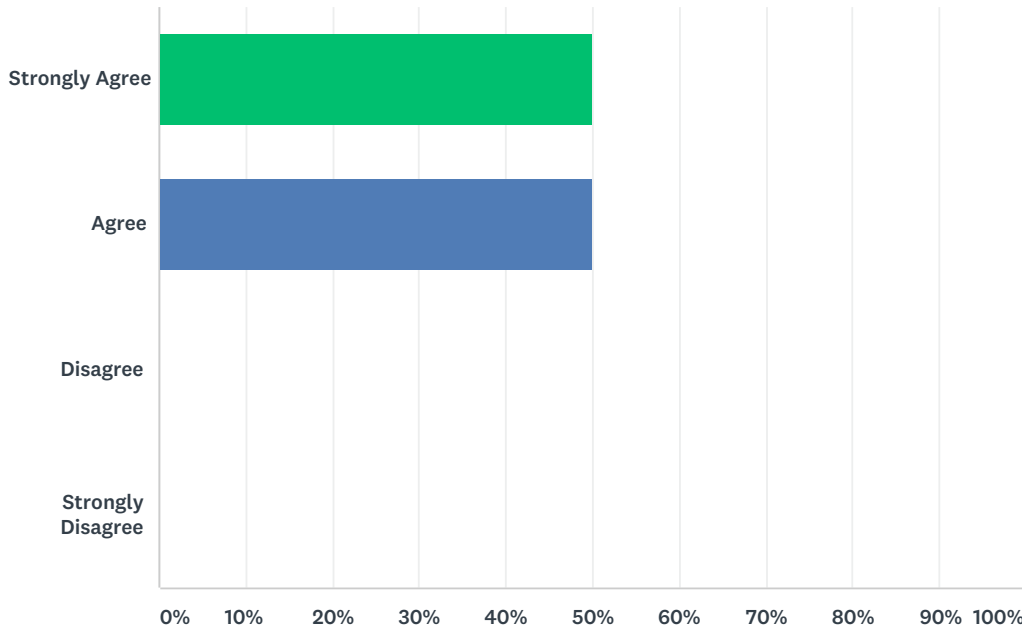

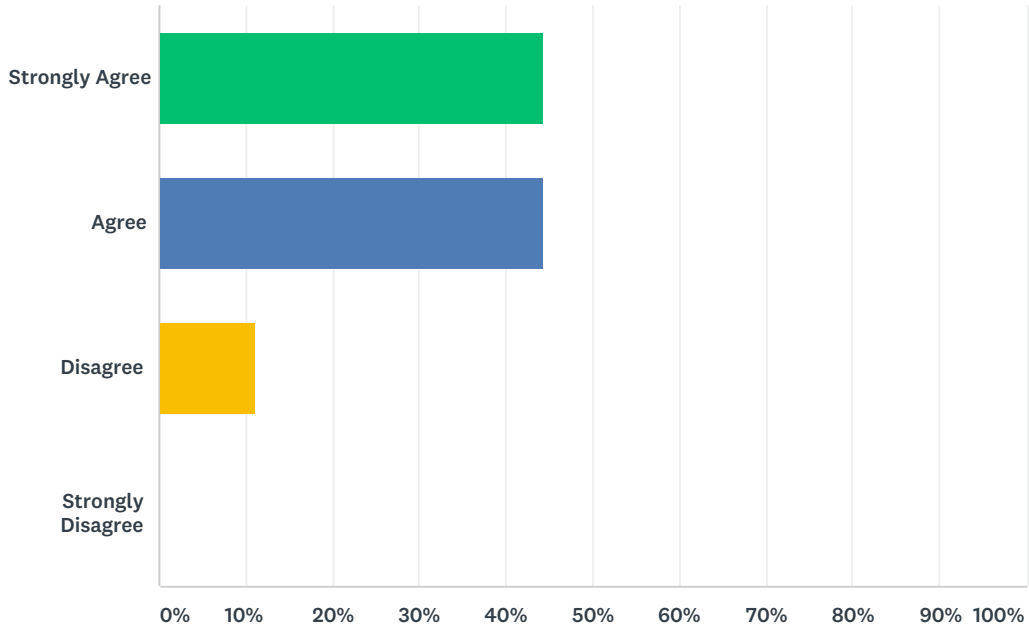
