This item is to receive current budget updates. Jane asked everyone to review the budget report (for 5 minutes) that was emailed to everyone from Forrest Alvarez before the discussion. Forrest emailed all members with "Subject: ASHC Reminder"

### 3.02 Scholarship Donation to Foundation

#### President Hdz

#### Action

This item is to approve the amount that ASHC will contribute to student scholarships. Apolonia recommended that we donate \$5,000 since we still owe \$15,000 that was donated last year.

David O. asked how much we have in the account and what was the foundation's original ask.

Augustine stated that we have \$189,947 and that the original ask was \$20,000

Augustine said we have projected revenue of \$65-70,000 for next year from student fees compared to past years is not much.

He suggested that we stay 5 months ahead of expenses to run the ASHC "household."

Juan asked where the money goes and suggested that \$5,000 is too low.

David O. suggested we donate \$20,000 to the foundation because if we give \$20,000 then there will be a stronger incentive for donors to match the amount at the scholarship fundraiser which will theoretically put \$40,000 back into the student aid.

Apolonia rebutted that the scholarships aren't given to all students – they're given to some students and that the ASHC events are for all—free prizes and free food.

Augustine mentioned in the past \$10,000 was given by ASHC, and the money went out according to student discretion.

He suggested we could give x-amount of dollars for y-purposes or that we can give them the money and decide how we want them to spend it in the future.

Guillermo asked if the money was allocated and Augustine said no, the money comes from student activity fees, so they aren't revoked at the end of a term.

Everybody

Juan said \$10,000 is a good amount, David Parmley suggested we should meet halfway, but not overextend ourselves, Guillermo said that \$10,000 was a good amount, David O. suggested \$20,000, and Jane thinks \$10,000 is a good amount.

Laura motioned to approve \$10,000 for the foundation scholarship fund

Apolonia seconded

The motion approved with 8 yes
